In the identified area, the current year population is 106,433. In 2010, the Census count in the area was 110,768. The rate of change since 2010 was -0.43% annually. The five-year projection for the population in the area is 103,034 representing a change of -0.65% annually from 2019 to 2024. Currently, the population is 47.9% male and 52.1% female.

Currently, 67.2% of the 50,475 housing units in the area are owner occupied; 21.1%, renter occupied; and 11.7% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.4% are renter occupied; and 11.2% are vacant. In 2010, there were 50,475 housing units in the area - 63.6% owner occupied, 27.3% renter occupied, and 9.2% vacant. The annual rate of change in housing units since 2010 is 0.00%. Median home value in the area is \$113,266, compared to a median home value of \$234,154 for the U.S. In five years, median value is projected to change by 3.20% annually to \$132,610.
