Currently, 54.7% of the 35,445 housing units in the area are owner occupied; 32.5% are renter occupied; and 12.8% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.3% are renter occupied; and 11.3% are vacant. In 2010, there were 36,150 housing units in the area - 56.4% owner occupied, 33.1% renter occupied, and 10.5% vacant. The annual rate of change in housing units since 2010 is -0.87%. Median home value in the area is \$87,791, compared to a median home value of \$235,127 for the U.S. In five years, median value is projected to change by 1.79% annually to \$95,940.
